February 2021

The Arkansas Healthcare Transparency Initiative (HTI) **Arkansas APCD 20D database** is now available. The Arkansas APCD 20D release includes data through June, 2020. The [Data Coverage](#) table provides overall coverage periods. Some submitters within these categories have exemptions affecting their coverage. Refer to the [Arkansas APCD 20D Universe Counts](#) spreadsheet for submitter specific coverage information.

Note, hereafter, the release number will be included with database name, e.g. 20B. The Arkansas APCD is updated quarterly though only the second and fourth updates annually are available for release.

The Arkansas APCD quarterly releases can be identified using the following naming convention:

SOURCE SPECIFIC RELEASE NOTES

Certain submitting entities have been added or omitted from the Arkansas APCD for this release. Those omitted have data quality issues that are being resolved. These issues are significant, resulting in their omission from the database release until resolution. Once resolved, previously excluded submitting entities are included in subsequent builds.
